GKS Street Fair: May 19, 2024 – Vendor Rules

1. No one may participate without a signed contract and approved street space by the GKS Team.
2. No one may participate until all required permits, certificates, and paperwork have been submitted to the GKS Team & approved.
3. No one may sell alcoholic beverages without proper licenses and/or obtaining a temporary beer, wine and cider permit through the SLA.
4. The GKS Street Fair Team reserves the right to determine what is appropriate for sale on the street. Once approved, no substitutions or additions will be accepted without further approval.
5. No DJs. No live or recorded music or any amplified sound without prior permission from the GKS Team.
6. Prior approval for generators, barbecue grills, and open flame grills is required.
7. All stands are assigned by GKS Team. Sidewalks are required to be kept clear.
8. A straight 15-foot lane is required to run down the middle of the street by law.
9. All booths using propane must have an appropriate fire extinguisher on premises.

Additional Permitting Required

The GKS Team will help you with these permits. Please contact us as soon as possible to begin the process.

- **If you are selling merchandise:**
 - o You must have a Temporary Street Fair Vendor Permit
 - o Someone at your stand must be in possession this permit.
 - o Instructions on how to apply in-person or online: <https://nyc-business.nyc.gov/nycbusiness/description/temporary-street-fair-vendor-permit/apply>
- **If you do not have a Food Service Establishment Permit from the Department of Health and would like to sell/prepare/sample food:**
 - o You must have a Temporary Food Service Establishment Permit.
 - o Someone at your stand must be in possession of a Qualifying Certificate in Food Protection.

- **If you are a restaurant or bar with a valid liquor license that allows you to pour on premises and you would like to serve beer, wine and/or cider:**
 - o You must apply for and receive a Temporary Beer, Wine and Cider Permit (if you are not registered as a DOT Open Restaurant).
- **If you would like to cook/prepare/serve a whole animal and/or shellfish:**
 - o You must obtain a waiver from the Department of Health.
